GENERAL INFORMATION

SPECIAL CROP MIX 1 chelated micronutrient contains 1% CU, 3% MN AND 5% ZN in a fully chelated form readily available to plants. It is recommended for use as an additive in liquid fertilizer and can also be used as a foliar spray. SPECIAL CROP MIX 1 is compatible with herbicides, insecticides, fungicides and most agricultural chemicals that may be utilized in combination with liquid fertilizer. SPECIAL CROP MIX 1 is most effective when placed in the root zone during planting or moved into the soil by irrigation, tillage or rainfall. It is important that the micronutrient deficiency be treated before visual symptoms appear to insure proper yields. Rates of application will vary depending upon the severity of the deficiency, climate, soil conditions, and method of application. Consult your State Agricultural Experiment Station or Extension specialists for advice in selecting treatments from this label to best fit local conditions.

HOW TO APPLY

Soil Application: SPECIAL CROP MIX 1 can be applied in water or in combination with liquid fertilizer for pre-plant, starter or side dress applications. The most effective treatment of row crops is soil applications in a band at planting time or as a side dressing shortly after planting. For dry fertilizer applications use Ruffin-Tuff granular micronutrients.

Foliar Application: SPECIAL CROP MIX 1 diluted with water according to label recommendations, can be applied as a foliar spray. To insure even distribution on the leaf surfaces and increase the effectiveness of foliar application a small amount of wetting agent or detergent may be added.

NOTE: Foliar Spray of SPECIAL CROP MIX 1 should not be considered a substitute for soil application but rather a supplement or temporary measure to correct zinc deficiency in most crops.

RECOMMENDATIONS FOR USE

This product is for use on all food and fiber crops. These are general recommendations. Consult your local agricultural professional or RSA's Use Guide for this product for specific recommendations.

GENERAL RECOMMENDATIONS

SOIL APPLICATION

Deficiency Level	Rate Banded	Rate Broadcast
Mild	1-2 qt/acre	1-3 qt/acre
Moderate	2-3 qt/acre	3-5 qt/acre
Severe	3-4 qt/acre	5-8 qt/acre

FOLIAR APPLICATION

Dilute 1/2 to 1 gallon of product in 100 gallons of water and spray to thoroughly cover foliage.

CAUTION: Keep out of reach of children.

MIXING INSTRUCTIONS

Add 1/2 of water and/or liquid fertilizer to mix tank. Start agitation. Add correct amount of SPECIAL CROP MIX 1. Add remainder of fertilizer and continue strong agitation until mixed. Other chemicals, if used, should be added after the fertilizer-micronutrient mix has been prepared.

If there are questions regarding compatibilities of other substances with SPECIAL CROP MIX 1, conduct a jar pilot test to determine the mixing characteristics of the different materials.

NOTE

A number of variables influence the rate of application necessary to control or correct a specific deficiency. For best results follow good agronomic practices, soil test and, if necessary, use tissue analysis.

SPECIAL CROP MIX 1 is an acid based chelate and is corrosive to mild steel. After the material is mixed in liquid fertilizer its corrosiveness is buffered by the fertilizer. SPECIAL CROP MIX 1 MUST BE STORED AND/OR SHIPPED IN STAINLESS STEEL, FIBERGLASS OR POLYETHYLENE TANKS. The tank fittings used must be PVC or stainless steel.
